EALING Mid-Term Event "Towards a harmonised onshore power supply in the European Union"

On 29th April the EALING Mid-Term Event "Towards a harmonised onshore power supply in the European Union" was held digitally. It was the opportunity to share the first outcomes from EALING *Activity 1 – Harmonised framework for the electrification of participating TEN-T maritime ports*, *Activity 2 - Maritime fleet adaptation* and *Activity 3 - Technical studies for the electrification infrastructure of the participating TEN-T maritime ports*. They were discussed with all the relevant stakeholders involved in building a more competitive and sustainable TEN-T Maritime Network. EALING Eastern Mediterranean Stakeholder Workshop

During the Posidonia International Shipping Exhibition (Athens, 6th-10th June), EALING held the **Eastern Mediterranean Stakeholder Workshop** titled ***EALING: Electrification in Ports and Vessels – Challenges and Sustainable Solutions in Europe***.



The workshop's objective was to provide an **all-round inspiring environment** and a **multi-disciplinary forum** for the exchange of knowledge and expertise on **Electrification in Ports and Vessels**, focusing on challenges and sustainable solutions in Europe. During the discussion the panelists highlighted issues such as the **unique characteristics of each port**, the **availability of alternative fuels and their respective bunkering infrastructure**, and the **role of the supply chain** that should ensure sustainability with holistic end-to-end solutions that cover all aspects of maritime risk.
